# REGIONAL HOUSING AUTHORITY OF SUTTER AND NEVADA COUNTIES Minutes Special Board Meeting April 30, 2013

#### ITEM NO. A - CALL TO ORDER:

Chairperson Diane Hodges called the meeting to order at Yuba-Sutter Economic Development Corporation, 1227 Bridge Street, Suite C, Yuba City, CA 95991.

#### ITEM NO. A - ROLL CALL:

Ms. Nichols explained the bonds for the TRIO program have not sold but there is another lead for the financing.
