# REGIONAL HOUSING AUTHORITY OF SUTTER AND NEVADA COUNTIES Minutes Regular Board Meeting January 16, 2013

## ITEM NO. A - CALL TO ORDER:

## ITEM NO. E. - ADMINISTRATIVE UPDATE:

Executive Director Linda Nichols stated the Hans Miller Building has been torn down. She said HUD is planning on releasing some information on the sequestration but in the mean time Housing Authority's will continue to budget on the 2012 level. She also mentioned union negotiations will be starting at the end of the month.

Ms. Nichols stated Maple Park is approximately 99% complete. Staff is working on the final offer for the Mental Health Housing in Marysville. She also said TRIO will be sending out the bonds for funding in February. Ms. Nichols said she is hoping to do a tax credit application for Richland Phase I.
