

**ATTENTION OWNERS/DEVELOPERS
INVITATION FOR PROPOSALS**

Regional Housing Authority (RHA) invites developers of property in the Town of Truckee to submit proposals for participation in the **Section 8 Project Based Voucher Program (PBV)**. The primary purpose of this allocation is to create new rental units that are safe, decent and sanitary for rental to low income families. Higher ranking will be given to new construction projects located in the Town of Truckee; however, projects outside of the preferred scope will be considered.

If applicable, all financing of project costs and operating expenses will be the responsibility of the owner. Rents that are established for the project will be commensurate with other comparable rents for similar rental units in the areas in which the project is located. In all cases, however, rents cannot exceed the maximum allowable HUD Fair market Rent published for Nevada County.

The PBV units will be leased to eligible low income households referred by RHA or to eligible tenants in occupancy of the unit at the time of the submission of the proposal. **Rental assistance is available for a total not to exceed 10 units. RHA reserves the right to award less than the maximum vouchers available or requested.**

Note: Participation in the PBV Program requires compliance with Fair Housing and Equal Opportunity Requirements, and Federal Labor Standards will apply to eligible projects.
