

**ATTENTION OWNERS/DEVELOPERS  
INVITATION FOR PROPOSALS**

Regional Housing Authority (RHA) invites developers of property in the City of Yuba City to submit proposals for participation in the **Section 8 Project Based Voucher Program (PBV)**. The primary purpose of this allocation is to create new rental units that are safe, decent and sanitary for rental to low income families. Higher ranking will be given to new construction projects located in the city limits of Yuba City; however, projects outside of the preferred scope will be considered.

For rehabilitation, each unit being rehabilitated requires a minimum expenditure of \$10,000, including the unit's prorated share of work to be accomplished on common areas or systems, but priority will be given to projects committing over \$15,000 per unit in improvements. There is no limit on expenditures for new construction. All financing of project costs and operating expenses will be the responsibility of the owner. Rents that are established for the project will be commensurate with other comparable rents for similar rental units in the areas in which the project is located. In all cases, however, rents cannot exceed the maximum allowable HUD Fair market Rent published for Sutter County.

The rehabilitated/newly constructed units will be leased to eligible low income households referred by RHA or to eligible tenants in occupancy of the unit at the time of the submission of the proposal. **Rental assistance is available for a total not to exceed 43 units.**

**Note: Participation in the PBV Program requires compliance with Fair Housing and Equal Opportunity Requirements, and Federal Labor Standards will apply to eligible projects.**
