Background:

On May 16, 2018, the Board of Commissioners of the Regional Housing Authority approved the award of a contract totaling \$31,562.00 to Ace Environmental Management, Inc. This award included both the hazardous material removal and the demolition of the building.

After further review, staff determined that it may be more cost effective to bid the hazardous material removal separately and conduct the demolition phase at a later date. An alternative is for agency staff to rent the heavy equipment and conduct the demolition project in-house.

Staff reached out to potential bidders for new bids for the hazardous material removal only, and the low bid totaled \$11,500.00. The bidder is West Coast Environmental (Rancho Cordova, CA).

The new bid is \$3,912.00 lower than the previous low bid for the removal of the hazardous material. Staff's belief that bidding the hazardous material removal as a stand-alone project would be lower, held true.

Staff's in-house cost estimate for the project scope of work totaled \$20,836.35.
