ITEM NO. H.9. – RESOLUTION 25-1866 – AUTHORIZATION TO CONSOLIDATE LAKE COUNTY HOUSING  
CHOICE VOUCHER PROGRAM WITH REGIONAL HOUSING AUTHORITY:

Executive Director Gustavo Becerra shared that Lake County Board of Supervisors approved staff's recommendation to consolidate with Regional Housing Authority. Once both boards approve the respective resolutions, staff will submit a joint letter to HUD for their approval. Mr. Becerra said there are only two dates that the conversion can happen which are July 1 or January 1. Staff would like to take advantage of the July 1 date if HUD allows it.

Mr. Becerra said Lake County is also interested in the Project Based Voucher side of the program. He mentioned if this is all approved, the JPA will need to be updated and there may be two new board members to our board. Mr. Becerra stated there are approximately 220 vouchers and currently there are 179 vouchers being utilized.

ITEM NO. I. 12. – ADMINISTRATIVE UPDATE:

Mr. Becerra shared the Pacific Crest Commons closing will be towards the middle to end of May 2025 to start construction before the snow falls in Truckee. She stated the Rancho Colus ribbon cutting took place yesterday and thanked those Commissioners who were able to make it. Mr. Becerra said tax credits and tax-exempt bonds were awarded for the Richland Village project. He stated due to the financing difficulties; the project was reduced from 176 units to 133 units.

Mr. Becerra stated he cannot say much due to legal issues but wanted to let the board know that there is an investigation with the State Civil Rights agency regarding the information received from the Kristen Court resident. He assured the board that the employees are not Regional Housing Authority employees. Mr. Becerra said there is also an internal investigation with the onsite manager.

Commissioner Woten was surprised to hear about the situation at the Kristen Court Apartments. He shared that Jack in the Box has opened in Live Oak. Commissioner Woten said he is amazed with the staff and the amazing job they do.

Commissioner Blaser said there is a community center set to be built on the corner by the Cedar Lane Apartments.

Commissioner Chapdelaine said it was good to see everyone and thanked staff.

Commissioner Vasquez said it is good to see people working together in a successful organization and moving into new areas. He stated it was an honor to be here and to see this is a solution-oriented organization with great work by staff.

Commissioner Gallaty said she appreciates staff and the board.

Commissioner Cardoza stated the ribbon cutting was a wonderful event. He congratulated the new Chairperson and Vice-Chairperson. Commissioner Cardoza thanked Mr. Becerra and staff for keeping the projects coming and getting the funding to do the various projects.

#### ITEM NO. I. 8. – RHA OWNED/MANAGED PROPERTIES OCCUPANCY/ELIGIBILITY UPDATE:

Occupancy Manager Pattra Runge said the vacancies were filled very quickly. She mentioned there are highlights listed in her report for some of the tax-credit properties as well as the properties she manages. Ms. Runge said there was an easter egg hunt at Richland Housing. She mentioned opening day of the Office of Migrant Services units was very successful and only seven vacant units were available at the end of the day. Ms. Runge shared there is currently one vacant unit available.

Commissioner Vasquez really appreciated the efficiency of the process to lease up so many families in one day. Commissioner Cardoza said the staff is great, it was a smooth transition for those leasing up. Commissioner Cardoza shared the grounds were immaculate and he would be honored to live there.

#### ITEM NO. I. 9. – HOUSING CHOICE VOUCHER ELIGIBILITY/OCCUPANCY UPDATE:

Occupancy Manager Alisha Parker said the number of Port-Outs (families moving to another area) has increased but families are no longer able to move to a higher cost areas unless the voucher is absorbed. She said the Section 8 waiting list remains open and will remain open until there are approximately 7,500 applicants on the waiting list.

Executive Director Gustavo Becerra shared there is a group of Housing Authorities advocating for a change in regulations regarding the portability issues. He mentioned if a family decides to leave our jurisdiction and port to another area that is not absorbing the voucher, the Regional Housing Authority (RHA) must pay for the rental assistance in that new area. Mr. Becerra explained this can be very costly when the family moves to a higher cost area. He mentioned that with one payment in a higher cost area; RHA could be assisting two to five families in our jurisdiction. Mr. Becerra said the congressmen for our jurisdictions are infuriated by the HUD regulations allowing the federal tax dollars leaving our jurisdictions to reside in another jurisdiction and use the monies allocated for our residents.

#### ITEM NO. I. 10. - MAINTENANCE UPDATE:

Operations Manager Tony Langlois stated the unit turnover numbers are very similar to last years numbers. He said preparations have started at the trailer park in anticipation of the new Richland Village development with the removal of trees and debris. Mr. Langlois mentioned there have been several sewer lateral replacements, replacements of two sections of damaged storm drain, installation of four tankless water heaters and the renovation of one bathroom over the last quarter. He also stated the storm drain pump station operated without any issues during the entire rainy season.

#### ITEM NO. I. 11. - ADMINISTRATIVE UPDATE:

Mr. Becerra shared the resolution for the Lake County consolidation will be going to the Lake County Board of Supervisors later in the month. He said staff is pushing for a July 1, 2025 effective date but it will more than likely be a January 1, 2026 effective date. Mr. Becerra stated if the consolidation does not take place on July 1, 2025, Lake County Housing Authority has asked the Regional Housing Authority to be a contract administrator for their Housing Choice Voucher program until the effective date of January 1, 2025.

Mr. Becerra stated the Pacific Crest Commons construction loan closing should be mid-May. He shared this is a 55-unit project in Truckee, CA. Mr. Becerra mentioned Nevada County staff received a call from HCD

stating there was no need to apply for tax credits because they have funds for the 31-unit Lone Oak II project in Penn Valley. He said the project could close in 180 days for a possible construction start of late summer/early fall.

Mr. Becerra mentioned the construction costs for the Richland Village project in Yuba City, CA are higher but not as bad as were anticipated. He shared construction may start in the fall once the construction financing has closed in September or October. Mr. Becerra shared the Section 8 waiting list is still open. He said it was great teamwork with staff for the opening day of the Office of Migrant Services units. Mr. Becerra introduced Tony Langlois to the board.

Mr. Becerra said the Plumas Lake project was fully leased within thirty days. He stated the Williams project is looking to be completed in mid-June.

#### ITEM NO. J - HOUSING COMMISSIONERS' COMMENTS:

Commissioner Vasquez said this is an exceptional board and the success rate is great.

Commissioner Cardoza thanked staff and shared he is very impressed with the properties. He stated it would be a wonderful place to live.

Commissioner Blaser mentioned there has been a lot of work done on the baseball field in Marysville and there will be a ribbon cutting for the Yuba Sutter High Wheelers baseball team tonight.

Commissioner Boes mentioned the Rancho Colus ribbon cutting was fantastic.

Commissioner Chapdelaine shared the City of Live Oak is currently recruiting for a City Manager but has an interim City Manager in the meantime. He stated there was a food truck event in Live Oak. Commissioner Chapdelaine mentioned he recently visited the museum for their 50-year anniversary.

Commissioner Woten said things are moving in a positive direction for the City of Live Oak. He is amazed by the staff and the great job they are doing for the top down and appreciates everyone.

Commissioner McFarlane said it is nice working with a group of people who are professional and gets things done.

Vice-Chairperson Hoek said fire season is almost here. She also mentioned how tough it is to build affordable housing.

Chairperson Conrado said the Planning Commission in the City of Colusa will be meeting tonight to discuss the second phase of Rancho Colus.
